1. Welcome and Apologies for Absence

The Chair formally welcomed everyone to the meeting. Apologies received and accepted from Borough Cllrs Woodford, Hunt and Clarke, PCSO's David Ansbro and Kirsty Linge.

b. County and Borough Councillors

- *i.* County Cllr. Baldock advised the following:
- KCC have issued their budget and there is a lack of support provided for buses. This affects the Gadby Road service and Cllr. Baldock is trying to get a diversion from Kenilworth Road.
- There have been further budget cuts for Community Wardens.
- The government does not provide enough money to support roads and highways.
- A meeting took place with the Joint Transportation Board to discuss the Bobbing interchange, this can now go out to consultation.

- Swale Borough Council have frozen staff wages and are moving to a 34-hour working week.

- 3. PCSO Linge Bobbing Report: Crimes of note:
- 09-02/23 Bobbing services Reports of shoplifting at the Petrol Station shop. Crime report has been taken and is under investigation.

Anti-social behaviour and other incidents of note:

- 06/02/23 Stickfast Lane 2 females were parked up in Stickfast Lane. A van with 3 males pretending to be plain clothes Police Officers pulled up the males came over to the car and began speaking to the females asking if the car was registered to them. When the females challenged the males, they started laughing and left.
- 08/02/23 Bobbing Hill reports of 2 large black dogs roaming around the road, potentially from Pigeon. Farm Inft advised to contact SBC dog warden.
- 08/02/23 Demelza House –Staff at the location reported vehicles meeting in the car park of Demelza House and potentially dealing drugs. Details of the vehicles have been given to Police for further enquiries.
- 10/02/23 Parsonage Lane reports of various cars meeting and potentially drug dealing. Local officer aware and paying passing attention.
- 12/02/23 Stickfast Lane RTC, 2 male occupants arrested by Police.
- 12/02/23 Bobbing Crem Alarm going off at the location. Everything all in order.
- 18/02/23 Sheppey Way near Bobbing Breakers 2x dirt bikes causing issues, driving recklessly. Officers attended but were unable to locate the bikes.

3. Minutes of the Previous Meeting

5. Matters Arising from the Minutes and Last Month's Meeting

- 1. **H.I.P** Cllr. Baldock attended a meeting with KCC and discussed the Bobbing Apple junction he advised he would like Highways to keep to the plan of a new roundabout at this junction.
- Bobbing Village Plan No update but meetings are being held for residents to discuss this, the next being 25th March at Bobbing Village Hall. Bobbing Parish Council will pay for the hire of the hall, proposed by Cllr. Morgan-Brown and seconded by Cllr. Clare.

6. Parish Councillors' Reports

Cllr. French advised the road works are still in place at Sonora Way and re-surfacing work has begun on the Zebra Crossing.

Cllr. Herbert reported there is still a high amount of litter on the A249 embankment and asked the Clerk to contact National Highways. He also reported there are piles of earth around the Demelza House estate. Clerk to contact the Developer and Kent County Council planning enforcement to find out how they plan to use it.

Cllr. Clare expressed her concern over the build-up of traffic along Chestnut Street.

- Eden Top Council members discussed a licence application from Eden Top for 1 goods vehicle and advised the Clerk to contact Hilcrest House and the Planning Department to ensure the correct procedures have taken place.

8. Planning Applications

23/500430/FULL: Change of use of existing public house to 1no. residential dwelling and a commercial workshop, including erection of a detached ancillary showroom. ADDRESS: Dancing Dog Saloon Sheppey Way Bobbing Kent ME9 8QP. Bobbing Parish Council do not object to the above planning application but advise that the following conditions should be observed: Business opening hours. Noise and pollutions levels.

23/500616/FULL: Erection of a two-storey side extension. ADDRESS: 1 Norwood Walk West Sittingbourne Kent ME10 1QF. Bobbing Parish Council objected to the previous planning application in 2019, and council members object to the above planning application. The reasons for the objection are: The proposed extension would block light to neighbouring properties. The proposed extension would overlook neighbouring properties. Could lead to more parked cars increasing congestion on the road. The property would be out of character for the area. Southern Water have problems with sewage in the area and it is known by residents that the drainage capacity is not the correct specification for the area. The increase in property size could add to the existing problem.
