- 2. County and Borough Councillors County Cllr. Whiting reported Highways England (HE) will put a holding objection to any housing development application that adds to traffic along the A249 corridor. Current holding objections are against a number of developments including at Chestnut Street. KCC is in discussion with HE to get a dispensation for the Aspire Special School, currently blocked by HE.

Re a proposal to expand Bobbing village by some 2,500 houses as part of the new Swale Local Plan he attended a presentation for councillors by the developer and understands it this is a conceptual proposal on land not designated for housing in the current local plan. No planning application submitted. Swale's local plan is up for review and needs to be published in April 2022.
