1. Welcome and Apologies for Absence

The Chair formally welcomed everyone to the Zoom video conferencing meeting. Apologies received and accepted from Parish Cllrs. Major and E. England, County Cllr. Whiting, Borough Cllr. Woodford and the PCSOs (who could not attend due to Kent Police not supporting the use of Zoom because of security).

2. Visitors/Public Time

Residents, County and Borough Councillors, PCSOs and Community Wardens were advised that they could attend as normal but public speaking time might be limited; they were also invited to forward reports/questions to the Clerk beforehand.

- 1. **Residents** None attended, and nothing raised.
- 2. County and Borough Councillors County Cllr. Whiting written report Expressed concern that Sittingbourne is not included in the 1,000 vaccination centres named by Government. He suggested looking at https://www.kentandmedwayccg.nhs.uk/your-health/coronavirus/covid19vaccine which is updated daily and best explains how NHS will roll the vaccines out in the weeks ahead. Mass testing is now available to all residents in Swale, a new test centre opens this week in Kemsley. He urged everyone to get tested. The Consultation regarding improvements to Key Street junction and Grovehurst junction runs until 26 January 2021. - 3. **Community Warden/PCSO** Community Warden No report.
- 4. PCSO's Bobbing Crimes of note: Vehicle stolen from Sheppey Way (near the school) during the day. A crime report has been taken and the investigation is ongoing. Report of a drunk driver in Ladyfields Close. Patrols attended and person arrested. Anti-social behaviour and other incidents of note: Report of two young boys running in front of traffic, playing 'chicken'. Patrols attended but did not find anyone in the area. Report of possible sexual activity in vehicles in Belnor Avenue over a couple of evenings. Police are aware, but there have been no further reports since the beginning of December. Cllr. Ball expressed his concern about the number of crimes in the area; sheds were being broken into, thieves used fields as a means of access at night; this is affecting both Bobbing and The Grove.

Cllr. Clare advised the Grove has been quite quiet. Had problems with a 4x4 and small bike racing around The Grove, they then headed over towards Sonora. Small gas canisters had been found in the Bobbing Hill.

Cllr Ball had residents approach him regarding rubbish; both Sheppey Way and Parsonage Lane are in a dreadful state. Sheppey Way is mostly due to lorries; there are bottles of urine, tissues which have been used for toilet paper, discarded litter, action really needs to be taken. Clerk has chased Swale on numerous occasions, she will do so again.

9. Planning Applications

- 1. **20/502559/FULL**: Land on The North West Side of A249 Bobbing Sittingbourne Kent: Erection of 4 stables on concrete base and open menage measuring 40m x 20m. (Amended site address) The Council's previous objections still stand.
- 2. **20/505813/FULL:** Erection of a replacement dwelling house including orangery gymnasium and creation of a new access point: Webbenditch Cottage Cold Harbour Lane Bobbing Kent ME9 8NN No comments.
- 3. **20/505883/LAWPRO:** Lawful development certificate for proposed siting of 2no. mobile homes, incidental to the main dwelling: Langdales Sheppey Way Bobbing Kent ME9 8QP no objections. To ask that the garden be reinstated when the mobile homes are no longer needed and removed.

Suggested project for 2021/22 Picnic Benches with wheelchair access. 2020/21 to 2021/22 cross over projects include Defibrillators for possibly three sites, Trees for Grovehurst and the Aspire Schools, and building material donations to the Village Hall to assist with the extension.
